John E. Fryde, the murderer of Andrew Peterson, was hanged at 10:55 Thursday morning, and in 15 minutes from the time the trap fell he was pronounced dead by the physicians. It was not until he was on the gallows and taken in charge by Coroner Dean.

**Fryde's Last Night on Earth.**  
John E. Fryde, as he sat in his little cell in the second story of the Crow Wing county jail on Wednesday evening last, before a reporter, who was the only newspaper man the prisoner would consent to see during the last 24 hours, who was to walk to the gallows in a few short hours.
