Washington, March 18.—Senator Proctor of Vermont, who returned last Sunday from an extended trip to the island of Cuba, made a statement to the senate of his observations on the island. The Millie Lane Indian Land question will be settled in the courts according to the following dispatch from St. Cloud:
St. Cloud, Minn., Special, March 18.
The Millie Lane Indian reservation lands will now be the basis of a number of suits to be instituted in the federal courts and in which the Indians will be made the plaintiffs.

It is understood that he will soon commence in behalf of the aborigines four different suits as test cases in the United States circuit court. One of these will be against Old Johnson, whose final proof papers are now before the department at Washington; another will be brought against a settler named Berg, who has received a patent from the United States for his claim; another will be against the state of Minnesota for possession of section 16 in township 36, and the remaining suit will involve the 4,000 acres on the reservation. These suits will be defended by the United States, and the settlers named will be made co-defendants.

Mr. Healdston states that a year ago he made a proposition to the settlers to bring about a solution of the difficulty and to give them a clear title to their lands by allowing the necessary lands to be allotted to the older Indians who object to being removed from the reservation.
