NEW WHOLESALE GROCERY HOUSE

Will Be Established in This City at Once by Dr. Hemstead and J. P. McGinnis

A THREE STORY SOLID BRICK Building Will Be Built on Ground Leased from the N. P. at the Corner of 4th and Front Streets.

Hon. Werner Hemstead and J. P. McGinnis, of this city, in company with W. H. Cleary, of St. Paul, have for several weeks contemplated the establishment of a wholesale grocery house in this city to supply the local trade and furnish the towns in this section of the state. These gentlemen desired to secure an advantageous site on the right of way of the N. P. for the location of their business and have been negotiating with the company for several weeks with this end in view, but not until Friday last was the deal closed.

They have secured a two year lease of ground 125 by 100 feet at the corner of 4th and Front streets, opposite Heese's implement office, on which they will immediately begin the erection of a solid brick block 100x75 feet, two stories high and an eight foot basement, making practically a three story structure. The building will be surrounded on two sides and rear with a ten foot platform, which will be covered to protect goods brought out ready to be shipped or delivered. The building will be equipped with a steam elevator and every modern appliance for the quick and economical handling

of goods, and it is hoped will be ready to commence business by July 1st.

A stock of goods of the value of between forty and fifty thousand dollars will be necessary to supply the trade. Mr. W. H. Cleary will be general manager of the business, while Mr. McGinnis will be treasurer and financial agent. Both of these gentlemen will give their personal attention to the business. The style of the firm will be Cleary, McGinnis & Hemstead.

The business will succeed and be a credit to the city there is not the slightest doubt. Dr. Hemstead and Mr. McGinnis are too well known by all the people of the city to need any words of commendation. They are both bright, intelligent, solid and conservative business men, with the necessary push and enterprise to succeed in anything they undertake. Mr. Cleary has, for the past 15 years, been on the road for McCormick & Bookke, the wholesale coffee and tea house, of St. Paul, and his extensive acquaintance with all the business men of the northern part of the state will be a valuable aid to the new business.

It is expected the new house will be ready for business by July 1st, and they expect to cover all the territory in the upper part of the state. Three men will be put on the road to begin with, but additional men will be made as fast as necessary. This is the second wholesale business established here within the past few weeks, and it is evident that Brainerd will be the jobbing center of northern part of the state before many years, as it is centrally located, and has transportation facilities in every direction.

NEW OPERA HOUSE AND CITY HALL

Will Be Built at Once By a Corporation Composed of Prominent Brainerd Business Men.

PROPOSITION TO CITY COUNCIL
On Monday Evening to That Effect—
Building Will Be Solid Brick and Located in Y. M. C. A. Park.

The people of this city are to be congratulated on the enterprise and public spirit of several of its most prominent business men. The city needs, and badly needs, both an opera house and city hall, but it has looked hitherto though neither could be obtained in the near future, because the former has never been a paying institution in this city, and the city had no funds to provide the latter, although badly needed. But the enterprise and public spirit of several of our citizens, headed by Hon. A. F. Ferris and Geo. D. LaBare, has not only made both possible but a reality, and both will undoubtedly be constructed at once.

These gentlemen on Monday evening submitted in writing the following proposition to the city council, which solves the matter, if the council accepts, of which there can be no question.

April 15th, 1901.
To the Honorable City Council of the City of Brainerd:

We, the undersigned, propose to undertake the raising of a sufficient amount above that which we ourselves subscribe for the purpose of having erected a solid brick building on the north side of the street between 5th and 6th, said building to cost between \$15,000 and \$20,000, and to be built for opera house and city hall purposes.

The opera house to be modern and to have a seating capacity of about 800. The city hall to be arranged similar to sketches herewith submitted.

The space for such city hall purposes to be not less than indicated by said sketches. The arrangement of city offices to be subject to the city council. The office of city clerk to be furnished with a first-class fire proof vault.

Provided, that the city of Brainerd will lease proposed city offices for a term of not less than five years and a rental of fifty (\$50) per month, and to furnish the necessary electric lights required for opera house purposes, which lights we propose to pay for at the present net domestic rates, prorated for the time lights are used. Mr. Ferris also addressed the council, explaining their proposition more in detail. Plans of the opera house portion and rough sketches of the city hall quarter were also exhibited for the inspection of the aldermen, who seemed to be very favorably impressed by the offer.

The matter was referred to a committee as reported in the proceedings of the city council. According to the plans the building will be constructed of solid brick 110x60 feet, the broad side fronting on Front street. It will be two stories high at the east end. The first floor will contain the entrance and lobby, and ticket office and manager's room. The city hall will be located in the second story and contain an office for the city clerk, with a large fire proof vault, and a council chamber and municipal court room. The center of the building will contain the auditorium of the opera house, with a seating capacity of about 800 in the parquet, and 300 in the gallery. The stage will occupy the east end of the building and will be large enough and roomy enough to accommodate the largest traveling companies. The opening will be 26 feet wide, 22 feet high, and 32 feet deep from the foot lights back. The height for scenery will be 22 feet high, five more than in the old Sleeper opera house; a height able to accommodate the largest scenery carried by any company. Two proscenium boxes will occupy either side of the stage. A basement will be constructed under the entire building. The hot air heating plant

will occupy the basement under the center, while under the stage will be constructed all the dressing rooms except two, one on either side of the stage for the stars. It is the intention to finish and decorate the auditorium in the finest manner, and supply the stage with all the latest and most modern equipments. About 250 incandescent lights will be used for lighting the building. When completed it will be the finest opera house in the state north of the Twin Cities.

While the gentlemen making the proposition are amply able and willing to carry out the enterprise themselves, they feel it would be better to get a large number of citizens interested financially, hence it is intended to organize a stock company and incorporate, and with this end in view subscriptions for stock are being solicited of all citizens who are willing to invest.

The Brainerd's opportunity and the council should not hesitate to accept the proposition. It will fill the two greatest needs of the city, without any cost to speak of to the taxpayer. Fine city quarters will be obtained for only \$600, less than the annual interest on the cost of bonds to build a city hall, and the indebtedness of the city will not be increased, and beside a fine place of public amusement will be provided, and incorporated, and with this end in view subscriptions for stock are being solicited of all citizens who are willing to invest.

The council committee to whom the matter was referred held a meeting last night and unanimously adopted a report recommending that the proposition be accepted, provided that the portion of the basement and the city quarters be fitted up for electrical supplies. A special meeting of the council will be held tonight to consider the report and take action.

THE WORK OF MISREBEANTS.

Two Attempts Made to Blow up the Gull River Dam—The Bridge Destroyed.

Two attempts were made last week to blow up the dam in Gull river where it leaves the lake, and the second trial resulted in the destruction of the bridge which is located right at this point. The explosive used was dynamite and the attempt failed only because the explosive was not properly placed.

The first attempt was made on Friday night, which did not do much damage, but on Saturday night it was tried again, with the result that the bridge was destroyed and the spring below the dam was badly damaged. The dam itself yet remains intact sufficient to hold back the waters of the lake.

There are ten million feet of logs in the lake to be gotten out this season, owned by various lumbermen, principally by Howe & Bonness, and it is said the effort to blow up the dam was made to injure these lumbermen, as it would be impossible to get their logs out without the head of water made by the dam. The gentlemen claim that there are parties at the lake who think they have a grievance against them, and believe they are the culprits who tried to destroy the property. They have employed a watchman who will remain at the dam day and night until the logs are out to see that no further damage is done.

OVER TEN MILLION DOLLARS

Will Be Spent by The Northern Pacific The Year To Improve

St. Paul Dispatch - President O. S. Mellett today authorized the Dispatch to make the first announcement relative to enormous expenditures which the Northern Pacific will make during the coming season.

The expenditures will aggregate \$10,550,000.

It sounds almost incredible, but the sum of \$10,550,000 will also be spent for rolling stock and similar equipment. It is the largest equipment order placed by a railroad company west of the Mississippi, and few Eastern roads can duplicate it.

The other five millions will be spent in permanently improving the roadbed from St. Paul to Portland in order that the line from end to end will be in perfect condition to bear the heavy strain of an ever-increasing volume of business.

These expenditures are the logical result of the rapid development of the northwestern and the extreme western country. The business of all the northwestern railroads has developed to such an extent, and the future shows such large increases still in sight, that the Northern Pacific feels that only by making such extraordinary additions to its equipment can it keep pace with the times. The expenditure of so much money on rolling stock is not looked upon in the nature of a risk. The business to keep the new equipment in active service is actually in sight, if not waiting.

The first item in the new equipment budget is sixty new cars for the various branches of passenger service. These cars will be built by the Pullman company. Included in this order are two ten-wheel motorized trucks with observation cars for the Duluth short line. All of the new passenger cars will be lighted either by electricity or by gas, gas excepting the second-class cars.

There will also be eight new sleepers. Thirty-two modern day coaches of the best type, fourteen motorized combination cars, two logging engine cars, two extra-fine dining cars, two parlor cars and two observation cars, fitted up in the sumptuous form of those now on the North Coast Lumber lines, and also between the Twin Cities and Duluth.

The additional freight equipment will consist of 4,000 cars. They will be built by the American Car & Foundry company in St. Louis and Detroit, Mich.

The new equipment is classified in the budget, as 800 extra long flat cars 44 feet for use under the long hauling contracts now in force with big Minnesota lumber concerns, 3,000 standard box cars, 450 coal cars, 150 refrigerator cars and 500 stock cars, a total of nearly 5,000 cars.

Two large steam shovels of the modern design will also be purchased, also two rapid balast loaders. The purchase of these would indicate considerable construction and betterment work.

The magnitude of the above order, covering a million and a quarter dollars, can be realized when it is stated that it will furnish employment for over 5,000 men in various parts of the country, for a period of six months.

WINTER PALACE BURNS

BUILDING OCCUPIED BY COUNTY VON WALKENBERG AT PEKING DESTROYED.

CHIEF OF STAFF CREMATED

General Schwartzkopf Loses His Life

By Returning to the Destroyed Structure—The Commander-in-Chief Escapes With Difficulty by Crawling Through a Window—Loses Everything but His Military Papers.

Peking, April 18.—The winter palace inhabited by Count von Waldersee and his staff, was burned to the ground. Major General Schwartzkopf, Count von Waldersee's chief of staff, has disappeared. With the exception of the military papers everything was destroyed.

Berlin, April 18.—A dispatch from Peking says that Count von Waldersee escaped from the burning palace of the emperor, which was destroyed by fire during the day, through a window with great difficulty. Major General Schwartzkopf, Count von Waldersee's chief of staff, appears to have lost his life by returning to the burning building after having escaped from it. Incendiarism is suspected.

ACCUSED OF DOUBLE DEALING.

Missionary Makes Serious Charges Against Li Hung Chang

Peking, April 18.—A missionary named Kilie has been accused in Ho, where Christians were burned to death in December. Mr. Kilie reports that the Chinese chief at some time ago some of his converts were killed. He had the guilty parties tried in the Chinese courts, where they were convicted and sentenced to death under the order of Li Hung Chang's signature. Mr. Kilie came to Peking and saw Li, who said the men should be executed immediately. Upon going to San Ho three weeks later the missionary found the men all alive. He spoke to a judge of the Chinese courts upon the matter, who thereupon showed him a letter from Li Hung Chang giving explicit instructions that the men must not be executed, as they had only been convicted on the testimony of Christians, consequently the evidence was untrustworthy. Mr. Kilie has a copy of this letter. In the meantime the French had proved the same men guilty of incendiarism and other outrages and demanded their execution, whereupon the judge again showed him orders from Li Hung Chang. The French authorities replied that if the men were not executed if they died they would take the law into their own hands and punish the Chinese officials who were the ministers of the foreign power.

The ministers of the foreign power were at a loss as to what to do against General Li Kwan Ting, as they think he will retreat, probably saving some villages he traversed and killing native Christians, and that such action will be used as an excuse by the military for further aggression and probably the taking of Tai Yui Fu, the capital of Shan province.

Captain Reeves, attached to the American legation here, accompanies the expedition to observe happenings on behalf of the United States.

At the meeting of the foreign ministers the question of indemnities was discussed. It is now estimated that \$700,000,000 will cover all claims.

LOOK FOR MORE TROUBLE.

Chinese Troops Missing Near the Frontier of Chi Li.

Peking, April 18.—Trustworthy Chinese report that troops in large numbers are missing in the province of Shan Si near the frontier of the province of Chi Li. Well informed natives prophesy further trouble. It is impossible to ascertain whether the court is playing a double game or its authorities are insufficient to prevent the Chinese generals acting in a manner likely to provoke hostilities. The fact that for many months there has been nothing in the shape of a definite government favors the latter hypothesis. Probably a great deal will depend upon the Franco-German expedition inflicting a severe defeat upon the Chinese who have transgressed the agreement by entering into the sphere of the allies. If these officers are thoroughly punished it is likely to produce a good effect.

CONVICTED OF CONSPIRACY.

Korean Minister of Justice Sentenced to Death.

St. Petersburg, April 18.—News has been received here from Seoul, Korea to the effect that the Korean minister of justice, Yi Non Ho, was arrested April 1 for participating in a conspiracy against the emperor of Korea. He named various high officials as accomplices in the plot. Yi Non Ho was condemned to death April 5 and the assistant minister of the Korean court was sentenced to 15 years' hard labor. The other implicated ministers were acquitted.

Many Thousands Unemployed.

London, April 18.—As a result of the commercial and industrial stagnation, says the Odessa correspondent of The Standard, "there were 30,000 persons unemployed in Odessa, 40,000 in Kharkoff and many thousands in other towns. These conditions cause the government anxiety as offering favorable opportunities for political agitation."

OVER HALF A BILLION

GOLD HOLDINGS IN THE NATIONAL TREASURY THE BIGGEST EVER KNOWN.

LARGEST LOT IN THE WORLD

No Other Financial Institution Has So Much of the Precious Metal on Hand—Russia at One Time Exceeded It but Has Less Than 400,000,000 Now—Has Nearly Doubled in Two Years.

New York, April 18.—The Evening Post says: "The summary of the United States treasury's report shows that the government's aggregate gold holdings, for the first time in history, have passed the \$500,000,000 mark. The exact total was \$500,378,564, of which \$257,575,000 was held against certificates in the hands of the outside world, and \$100,000,000 as a reserve against outstanding United States notes, the balance being free assets."

This is the largest amount of gold now held by any single financial institution in the world, and it is the largest ever held by any institution, with one exception—the Imperial bank of Russia—which in February, 1896, raised its total holdings to \$496,300,000, at present however, Russian bank holds only \$371,500,000. The Bank of France now holds \$472,371,000, its high record being \$479,344,000 on the 4th of this month. Most of the gold is held against outstanding notes. The Bank of England has \$129,300,000 gold and the high record of its history was \$141,500,000 in February, 1896.

Present gold holdings of the imperial bank of Germany are \$130,000,000, and its total assets had already exceeded \$278,000,000, as against the \$260,000,000 now held. On Feb. 10, 1894, they reached a low level of \$94,239,542.

WAS NO LONGER NEEDED.

Secretary Root Explains the Discharge of Russell Harrison.

Chicago, April 18.—A dispatch to The Record-Herald from Indianapolis says: Governor Durbin has received a letter from Secretary Root in which a full, explicit statement is made of the facts connected with the discharge of Russell Harrison from the army. Secretary Root says that he is a confederate with the president, directed the discharge of Colonel Harrison and that Adjutant General Corbin attempted in his official capacity to issue the orders. In inadvertence the discharge was made to take effect Dec. 1 instead of Dec. 15, a matter which the secretary regrets. Mr. Harrison's services were dispensed with by the secretary state, but he was no longer needed and for no other reason. The transfer of the government of Porto Rico from the military to the civil authority, with the consequent withdrawal of troops, required a reduction in the volunteer component, and as Mr. Harrison could not be retained in Porto Rico and there was no other place to assign him, he was given an honorable discharge.

ENDORSED BY STERNBERG.

Approves the Idea That the Mosquito Cases Yellow Fever.

Washington, April 18.—Sequoia General Sternberg has just given his approval without reservation to the report of the special medical board composed of Burgeon Reed, Carroll and Agratino upon the "Etiology of Yellow Fever," in which the conclusion was reached that the mosquito is responsible for the transmission of the disease. Moreover, the medical department of the army is moving especially to put into operation the methods of treatment and of prevention of yellow fever, involving a radical reversal of existing methods, which form the basis of the report.

Disastrous Steamboat Explosion.

San Francisco, H. C., April 18.—By the explosion of the boiler on the river steamer Ramona four persons were killed outright and six persons seriously injured. The dead include two women who were passengers on the steamer and two deck hands. Of the injured the purser and the mate will probably die.

Transport Garonne Heard From.

Washington, April 18.—The transport Garonne with Massachusetts volunteers returning from Manila has been reported. She was at Honolulu and will be in San Francisco in two days, according to the reports. The Garonne was long overdue and anxiety was felt for her safety.

Iowa Republican Convention.

Des Moines, April 18.—The Republican state central committee decided today to hold the next state convention at Cedar Rapids Aug. 7. J. C. Davis of Keokuk will be temporary chairman and A. L. McCall of Woodward temporary secretary.

Mexico Signs Peace Convention.

The Hague, April 18.—Mexico has signed the convention of the peace conference. China, Luxemburg and Turkey are now the only countries which have not signed the peace convention.

SLUING SANTA FE STOCK.

Pennsylvania Road Looking for a New Western Connection.

New York, April 18.—The Mail and Express says: "There is excellent authority for the statement that prominent men representing the Pennsylvania have recently bought large blocks of Atchison, Topeka and Santa Fe stock, and before long the former will be listed to name the principal directors of the latter company. These purchases are believed to aggregate more than 200,000 shares, largely preferred."

There are several reasons why the Pennsylvania should make such a move. For a long time it has had close traffic relations with the Chicago, Burlington and Quincy, but now that that company is about to pass into the control of the Northern Pacific and Great Northern companies the Pennsylvania cannot be so sure about the conservatism of its interests on transcontinental traffic.

POOL ROOMS RAIDED.

Committee of Fifteen Makes Another Head in New York.

New York, April 18.—The committee of 15 raided several alleged pool rooms during the afternoon. The raids were made on warrants issued by Justice Devens upon evidence obtained by the staff of detectives working for the committee under the direction of Superintendent John McCallagh. The raids in each case were personally supervised by one of the members of the committee, assisted by their own detectives and policemen of the regular force from the police in which the raid was made. In only one place did the committee obtain any arrests, and C. C. Brewster of the committee openly says the information of the place received a tip from the police.

TITLE TO ISLANDS.

Government Sends Special Agent to Porto Rico, Wis., to Investigate.

Madison, Wis., April 18.—J. J. Parks, special agent at Wausau, Wis., has received an order from the land office at Washington directing him to make an investigation of the islands in the Wisconsin river near Porto Rico with a view to ascertaining whether the islands are the property of the state of Wisconsin or of the United States government. The islands have been a subject of controversy between parties living in the neighborhood of Porto Rico and the neighboring states for 50 years. The evidence of title on the islands is the cause for the investigation, state and having acquired title to the property and refusing to take any action.

CANNOT BE FOUND.

Strange Disappearance of a Prominent Citizen.

El Paso, Tex., April 18.—There has been a great deal of activity in police circles here over the mysterious disappearance from a train of C. S. Bakersfield, Tex. Young was going to Houston, Tex., where he is interested in oil. Fifteen miles from El Paso his companions noticed that he was missing and a search was made to locate him and a notice was sent back to El Paso. His hat and valise were left in the coach and it is believed that he jumped or fell from the moving train.

It is almost certain that he was not killed by the train, as the body was not found after diligent search.

CONFIRMED BY STICKNEY.

Great Western Will Build to Sioux City This Summer.

Sioux City, Ia., April 18.—The Journal says James C. Stickney, general manager of the Chicago Great Western Railway, has authorized W. L. Stevenson, general manager of the Union Terminal Railway company, to say to the people of Sioux City that the Chicago Great Western would extend its line this year from Clarion, Ia., to Sioux City. Mr. Stickney said work would be started in 30 days.

Was Fatal to Four.

Vienna, T., April 18.—Four people were run down by the Missouri, Kansas and Texas river at a crossing eight miles north of Vienna. They were John Wilson, Mrs. Olive Wilson, their infant son and "Big Jim," an Indian, the driver. Wilson and the boy were killed and Mrs. Wilson and the Indian were fatally injured. The party was on route to Baxter Springs in a covered wagon. Wilson was a wealthy cattleman.

NORTHERN PACIFIC common stock reached par on the New York market Monday.

A primary court decision on Monday makes the average Dakota divorce worthless.

At Saug County saloons are required to have all screens and blinds removed during the hours in which they are supposed to be closed.

EX-CONFEDERATE M. B. Baldwin of this district, committed suicide at Seattle, Washington on Tuesday by shooting himself through the head.

W. W. WEST, editor of the LaSalleboro Journal, was on Friday appointed secretary of the state dairy commission. The appointment is worthily bestowed.

CHARIE NATION was arrested and fined \$500 in Kansas City Monday, the fine being suspended pending, she immediately left the city, which she did within fifteen minutes.

Some of our brethren of the press are now conducting the Hoisting-Lind deal for the purchase of the St. Paul Globe fell through on account of the capture of Aguinaldo. It is rather discouraging.

The lumber district of Northern Minnesota now so well covered by the Northern Pacific road is to be traversed also by the Great Northern and surveying parties are now out north and west of Cass Lake, Bemidji and other points.

The St. Cloud saloons were closed on Sunday last for the first time in nine years. Mayor Boyd of that city has fixed the hours in which his people shall go dry from 11 o'clock Saturday night until 1 o'clock Sunday afternoon.

THE DISPATCH this week publishes a supplement containing all the laws passed at the recent session of the legislature. As they contain some of the most important and beneficial laws enacted for some years, it would be well for all readers to carefully preserve them.

THE mayor of Minneapolis is not the whole thing after all. He permitted the slot machines to operate, but the county sheriff did not agree with him and closed them. Between the governor and the county sheriff Minneapolis will be fairly well governed in spite of the mayor.

New Election Law.

The following is an outline of the new primary election law under which party nominations in Minnesota will hereafter be made: The primary or nominating election is fixed on Tuesday seven weeks before the election at which the candidates nominated are to be voted for and the same day is fixed as the first day of registration. No elector may vote at the primary election unless he is registered.

At the primary elections congressmen, judges and members of the legislature, county and city officers, elective members of school boards, park boards and library boards are to be nominated.

The method of securing places on the primary ticket is extremely simple. The aspirant for office is obliged only to file his name and pay a fee. At least twenty days before the primary election any person who he seeks may file with the secretary of state...

If the office sought be a district office the candidate is required to pay to the secretary of state a fee of \$20. If voted for in a single county to the county auditor a fee of \$10.

Fourteen days before the primary election county auditors are required to group the names of the candidates filed with them, according to political parties, and have separate tickets printed for each party.

The method of voting is exactly the same as employed at a general election under the Australian system. Every registered elector is entitled to a vote, but unlike the present Hennepin law, he may receive only the ticket of one political party, and if challenged must swear that the ticket which he wishes to vote is that of the party whose candidates he generally supports.

Fourteen days before the primary election the names of the candidates are to be canvassed by the judge of election in the same manner that the ballots cast at general elections are canvassed, except that the tickets of the several parties shall be canvassed separately.

The tally sheets compiled after the Australian system are to be returned to the county auditor and by him to a canvassing board, which is required to meet two days after the primary election.

The canvassing board shall consist of the clerk of the district court, the county auditor, the chairman of the board of county commissioners and two trustees of the people of different political parties, to be selected, if possible, by the judge of the district court, provided, however, that none of the members of the board is a candidate for nomination at the primary election. In that case he shall be replaced by an elector to be selected by the judge of the district court.

Any elector who was a candidate for nomination at the primary election and was defeated may not secure a place on official ballot by petition.

The people of this city desire the free mail delivery system established and in order to secure the same the city council has taken all necessary steps in that direction by preparing a plan from which the correct numbers are to be obtained for the houses and business places. Signs have been ordered and will be here within a few days and will be placed at the intersection of every street in the city. The government demands that these street signs be in position and that the houses be numbered and the sidewalks in good condition in the districts to be covered by the free delivery before they will establish the same. While a large majority of the people have complied with the ordinance regarding the numbering of their houses the DISPATCH is informed that there are still a large number of residences unnumbered, and unless the matter is attended to at once it will materially interfere with the establishment of the service. The number costs but a trifle and there are none so poor but that they can afford the expense, especially when the convenience of having your mail delivered at the door free of charge daily is taken into consideration. If you have not procured a number do so at once and be in line when the government officials make an inspection of the city.

County Auditor A. Mahlum is making preparations to compile the list of descriptions of property affected by the act of the legislature authorizing the sale of all delinquent taxes bid in for the state at the last foreclosure sale, which included the taxes of 1895 and prior years.

Under the terms of the act any person interested in the title to the property can redeem it prior to Sep. 1, 1901, by paying one-half of the judgment obtained under the act of 1899.
