**WILL PROBABLY BE AIRED NEXT WEEK.**  
A Member of Northern Conference Marries His Own Step Daughter.

**DECIDES TO QUIT MINISTRY.**  
His Answer to Rev. Mr. Clow's Letter Brief and to the Point.

Among other things which are likely to be considered at the Northern Conference, of the Methodist Episcopal church, which convenes in this city next week, the case of Rev. J. G. Morrison, of the Franklin Avenue M. E. church of Minneapolis, a member of the conference, will probably be aired in good shape.

The following from the Minneapolis Times relative to his recent matrimonial episode sets his case before the public:

On Sept. 1, Great Morrison secured a license to marry Miss Maude Robertson, and the ceremony was performed by Rev. G. J. Valentyne, of the Park Avenue Methodist church. Great Morrison is Rev. J. G. Morrison, pastor of the Franklin Avenue Methodist church, and Miss Robertson is his step-daughter. Mrs. Morrison, the mother of the second Mrs. Morrison, died in February of last year and a few weeks after her death, there were reports that the pastor was about to marry his step-daughter. This report came to the newspapers, but strong pressure by influential members of the church prevented a publication of the report. It was said that Miss Robertson would be sent away and that the church would avoid unpleasant notoriety.

Mr. Morrison has decided that he will leave Franklin Avenue church and go to Duluth as a temperance worker. It is claimed that for this fact the matter would be aired at the northern Minnesota conference, which meets at Brainerd on Oct. 2.

During the Spanish-American war Mr. Morrison was captain of a company in the Fifteenth Minnesota. He has been a temperance advocate and has taken a prominent part at all the conventions of the party held in Minneapolis since he became a resident of the city. He has been connected with Franklin Avenue church for about three years.

Some time ago Rev. James Clow, of this city, who has had nearly all the work to do in connection with the coming conference, sent out a circular letter to all the members of the conference and in order to arrange entertainment, etc., it was necessary to ask some questions, which under ordinary circumstances would have been deemed pertinent. Among others a question asked in this circular letter was, "will your wife accompany you?" The answer Mr. Morrison was not married to his step daughter when that circular letter was received by him. He did not answer all the questions asked by Rev. Mr. Clow. He simply wrote opposite the above question, "No, she is in heaven." His case will probably be aired in this city whether or not he goes to Duluth to do missionary work in the slums.

Net Income for the Year Over Twenty-Three Thousand.

The Minnesota & International Railway company has filed its annual report with the railroad and warehouse commission and it makes a very good showing for the road.

The road operates 382.26 miles in the state running between this city and Benld and close its fiscal year with a surplus of \$45,770.97. Its income from operations during the year was \$144,678.08.

Gross earnings of the company which is a Northern Pacific property here, where \$632,005.01, of which \$265,656 was derived from freight traffic. Operating expenses were \$287,800.83, or 69.6 per cent of total earnings. Total deductions from the income account were \$126,605, leaving a net income for the year of \$23,078.

The company derived the greater part of its revenue from freight business, and during the year handled 94,621 tons at an average revenue of \$0.251 a mile.


