**CONGRESSIONAL CANDIDATES.**

As all right minded Republicans wished  
and expected, Gen. John T. Averill has been  
renominated for Congress in this Third Dis-  
trict. He was nominated by acclamation  
and unopposed, at the Convention in St.  
Paul on Thursday, a resolution of no un-  
certain sound commending him, and en-  
dorsing the able record he has made as our  
Congressman heretofore, was passed with  
great applause. Before sending our paper to  
press we have only time to give

Three cheers  
For Grant and Wilson,  
For General John T. Averill,  
For the whole Republican ticket, and  
For Republican principles generally.

Mark H. Dunnell has been re-nominated  
for Congress from the First District. His  
nomination was unanimous, and his election  
will be certain.

In the Second District a new candidate  
has been put forward for Congressional hon-  
ors in the person of Major H. B. Strait, of  
Shakopee. Major Strait will make an able  
man in Congress, and will honestly discharge  
his duties if elected. We know him well,  
and know him as every one who knows him,  
as a man of the finest business qualities,  
strict integrity, and as a hard, industrious  
worker in anything he undertakes. Know-  
ing the man, we feel sure he will be elected,  
and we think our old and warm personal  
friend Col. L. L. Baxter, should be put in  
nomination against him. Baxter would doubt-  
less be the strongest man in that Dis-  
trict as an opponent, but foregoing this, the  
Republicans have put forth a candidate that  
will sweep the field clean on election day—  
Baxter and all.

**THE MURDER OF MISS McARTHUR.**

Tuesday last at 2 o'clock was the day and  
hour set for the examination of the two half  
breeds confined in jail here, charged with the  
murder of Miss Helen McArthur. The  
family of the murdered girl, together with a  
large number of the citizens of Crow Wing  
and Little Falls were present, and as the  
hour drew nigh for the examination to com-  
mence, the court room was packed with citi-  
zens to witness the proceedings. The pris-  
oners were brought up from the cells below  
by Sheriff Gurnell, the complaint read, to  
which they both plead "not guilty." The de-  
fense for one of the prisoners—Te-be-ko-ke-  
shick-wab—asked further time, or an ad-  
journment, in order that certain witnesses  
might be procured which it was alleged  
would establish the innocence of this Indian  
—or half breed. After some argument up-  
on points of law governing adjournments, etc.,  
the court was adjourned until Thurs-  
day, the 25th inst., when a full examination  
into this case will doubtless be had. There  
was a very evident disappointment on the  
part of the crowd of spectators, at the ad-  
journment, as the case is one fraught with  
horrible details, without a doubt, and one  
in which the deepest and finest feelings of  
sympathy of thousands of people are enlisted  
—in the fate of this estimable young lady.

**REWARD OFFERED.**

The citizens of Brainerd, by private sub-  
scription, have raised about two hundred  
dollars, which they offer, (in posters, now  
being circulated) to any person who will find  
and produce the body of Miss McArthur,  
supposed to have been murdered by the two  
half breeds now in custody here. This is  
right, liberal, and just as it should be.

**INTERESTING LETTER FROM THE MIS-  
SOURI RIVER CROSSING.**

Horace Tribune—About the 20th of May  
I had my friends at Brainerd good-bye, and  
reluctantly (for a time only) severed the  
many pleasant ties of friendship formed af-  
ter a residence of a year and a half among the  
enterprising people of your thriving lit-  
tle city. For Brainerd, and her growth and  
prosperity I shall ever feel a lively interest.  
My destination was the new town at the Mo-  
River, and securing passage for Sioux City,  
Iowa, thither I was hurried as fast as the  
iron horse could carry us. On arriving there  
my first business was to procure passage up  
the Missouri on some one of the many steam-  
boats plying up the river. I found the first  
steamer Ida Stockdale, which had just been  
purchased by the N. P. R. R., was about to  
start up the river to the Mo. crossing, and  
although it was not the intention of W. E.  
Wellington, Supt. of the Transfer Dept., N.  
P. R. R. to take passengers, I secured pas-  
sage. Mr. Wellington had put the Stockdale  
in perfect order, and on our voyage up  
everything was kept neat and tidy as a lady's  
parlor. Mr. Wellington has as good a steam-  
boat record as any man in the west, and the  
Company is fortunate in securing him to or-  
ganize their Transfer Department. The trip  
was very pleasant, as one sees so much to  
interest and amuse. To-day a herd of an-  
telope, grazing like a flock of sheep; to-mor-  
row a cry of elk is raised, and all hands go  
for the pilot house, and then the scenery is  
ever charming, ever varied. After many  
days we pass Ft. Rice, and there we begin  
to look out for the famous town at the cross-  
ing. Somebody says, "I see tents," and  
away beyond the bend are seen the tents of  
Engineer Escalson, who is camped near the  
mouth of Heart River. We land and find  
that the town is six miles further up river,  
so still up we go. On arriving at Edwinton  
we find a real Minnesota community. Geo.  
P. Sweet is here representing the town inter-  
ests, while among the many residents we see  
many familiar faces. The question of where  
the crossing will be is the great question  
with the people here. About seven miles  
up and down the river, the land is covered  
with claim shanties, and every settler con-  
fident that the road will cross his claim, but  
time will settle the question. The popula-  
tion of this place is variously estimated at  
from three to five hundred, and is composed  
of mostly people from Minnesota and the pi-  
oneers up and down the Missouri. Nearly  
every boat down brings people from Monte-  
na, the upper country. The general  
character of the people here is the best that  
I ever saw in a new town. No disturbances  
or trouble have occurred here, and the law-  
less element that prevails so largely in new  
towns has no existence here. In fact I never  
saw so many men gathered together from  
different parts of the country that were so  
quiet and well disposed. There is every  
promise of a fine town here. The geographi-  
cal location, the fine land adjacent, the  
great amount of freight which must be dis-  
embarked here, all render it certain that  
here will be the town of the road, and al-  
ready business is increasing rapidly. If the  
line was located, or is located within thirty  
days, I believe winter will find us with a  
population of three thousand souls. Shaw,  
Cahner, & Co. have an immense stock of  
goods here, and several other parties have  
large stocks also, while of saloons there are  
only two. Prescott, Bly, & Co. of your city  
have a good saw mill in operation. Ayers  
& Sanbit, also of Brainerd, are here as  
general contractors, and every day brings  
new arrivals, both from Minnesota and along  
the line of the Mo. River, and the people  
are evincing that they have confidence in  
the energy and enterprise of the N. P. R. R.  
that the road will be speedily pushed for-  
ward to this point. I believe that Edwinton  
has advantages second to no point on the  
river, and would say to all come and see for

**EXTRAORDINARY SWIMMING FEAT.**

We have to record one of the greatest feats  
in swimming, which has ever come to our  
notice, and one performed in every par-  
ticular as stated below. On Tuesday last,  
at 1 o'clock P. M., the Rev. G. A. Gil-  
fillen, Rector of St. Paul's Episcopal Church  
at Brainerd, started from the railroad bridge  
across the Mississippi at this place, and  
swam without halting, to Crow Wing vil-  
lage, eighteen miles down the river. He left  
the bridge at exactly one o'clock, and ar-  
rived at Crow Wing at ten minutes before  
five o'clock, making the average miles in  
three hours and fifty minutes—or nearly  
five miles an hour. The current runs only  
at a fraction over three miles per hour, thus  
requiring him to overcome nearly two miles  
each hour faster than the current for nearly  
four hours successively. He was but little  
fatigued at the end of his "voyage," and  
could have gone much further, were it not  
that he had to walk back a distance of  
twelve miles, which he did the same even-  
ing, arriving at home about 8 o'clock. A  
man accompanied him in a birch bark can-  
oe and carried his clothes. If this can be  
done, from first to last, in any part of  
the country, we stand ready to listen and  
let the facts on record.

**PRIZE FIGHT.**

To amateur shoulder-knockers—profes-  
sionally termed "scrubs," we believe—had  
a regular ring fight on Tuesday last, near  
the river, north of the railroad track. The  
incontrovertible fact was witnessed by about  
two hundred sportsmen and citizens, and being  
of that class of exercise in Brainerd, a  
great deal of hilarity was indulged in as they  
followed the combatants to the field of ac-  
tion, as also on the ground. They stripped  
to the belt, and after many preliminaries, the  
knockouts entered the ring, shook hands,  
and struck a position. After considerable  
sparring and "almaze," the light haired youth  
went for the black mustache of his man,  
but on his way thither came in contact with  
the wrong man's mauler, when he proceeded  
to sit down all in a pile. He was severely  
caught (we believe that's the term) some-  
where in the region of the fifth rib. They  
both took a little rest, arranged their toilet,  
and when time was called they again waited  
up, each in front of the other, and set in  
with considerable show of business. After  
a good deal of sparring, black mustache  
waded in, and caught his antagonist some-  
where in the left breast, sending him reeling  
to his corner, and following him up, sent in  
a couple more blows on his labarboard jaw,  
doubling him up badly on his way to  
dirt. He was picked up by his seconds,  
carried to his corner and repaired. Time  
was again called, but the light haired pugil-  
ist was only able to wriggle into the ring,  
shake hands, and agree to quit without any  
additional laurels. Thus ended the first,  
and we hope the last "entertainment" of  
this kind in Brainerd; for prize fighting we con-  
sider one of the lowest barbarisms of any  
age.

**NEW POSTAGE LAW.**

By the recent act of Congress the postage  
on transient printed matter has been fixed  
at one cent per cent for each two ounces, or frac-  
tion of four ounces or fractional part there-  
of. By this change the postage on any paper  
(daily or weekly) printed in this city is re-  
duced to one cent to any part of the United  
States. The postage on unsealed circulars  
has also been changed to one instead of two  
cents. There has also been a change in the  
fees charged for issuing money orders.

**A FRUITLESS SEARCH.**

On Wednesday last a large party of citi-  
zens went from here and Crow Wing, to  
search for the remains of Miss McArthur, in  
the neighborhood of where she was last seen,  
which was a short distance this side of the  
latter village. It had been learned through  
Indian sources that the murderers, after ac-  
complishing their vile purposes had mur-  
dered her and sunk her body in one of the  
adjacent sloughs. Or, rather, tramped it  
down into the soft, marshy soil on the bor-  
der of one of them. But as two months  
have intervened since then, the marshes and  
sloughs have grown full of grass and other  
vegetation, little hope was entertained of  
finding the remains, to start with, unless by  
mere accident. The search was vigorously  
prosecuted until toward evening, when it  
was abandoned, and they returned. Even  
under the most favorable circumstances,  
however, little hope could be entertained of  
finding it, as so long a time, at this season of  
the year, would have left nothing more than  
the bones, to be found.

filled the cellar of the former home with  
earth, and leveled it off in its beautiful form  
and sodded it all around, conforming with  
the size and shape of the residence destroyed,  
and in the centre of this will be entombed  
the vessel containing the remains of the un-  
fortunate family. Thus will end forever a  
real and tragic drama of life on the frontier.
