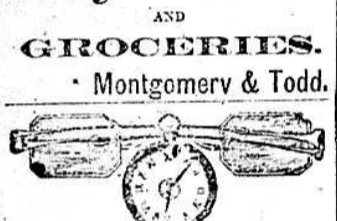

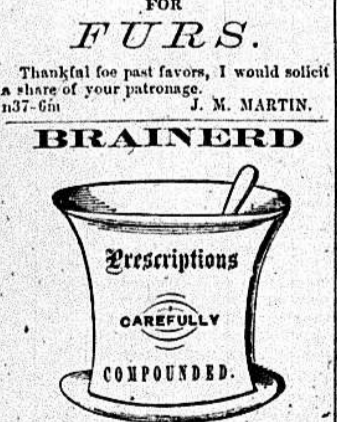

Court opened in due form.
Present, Hon. J. M. McKelvy, Judge; John Gurrell, Sheriff; W. W. Hartley, Clerk.
The Grand Jury was duly sworn and charged by His Honor, the Judge, and retired.
John Fouch, James Oleson and James Rush were appointed Officers of the Court.
Court adjourned for dinner.
1-15 P. M.—Court opened.
Petit Jurors list called, and absentees noted.
Motion to dissolve attachment in case of Ruffee vs. Mooers—argued by L. W. Collins, for defendant, and Attorney Genl. Cornell, for plaintiff. Held under advisement by the Court, and Court adjourned to Oct. 29, 8-30 a. m.
Oct. 29.—Court opened.
Case of Henry Keller vs. Henry Whipple, action for debt, continued from last term, continued to next General Term, by consent of counsel.
Louisa Lufkin vs. Henry Whipple, an action on appeal from Justice Court, continued, by consent.
Anna Lufkin, by her next friend, Louisa Lufkin, vs. Henry Whipple, an appeal case, also continued.
State of Minnesota vs. Justis A. Wilson—motion for continuance, by defendant. Argued by L. W. Collins, for defendant, and Attorney Genl. Cornell, for prosecution. Held under advisement by the Court.
Recognition of W. M. Dawson, witness in above case, declared forfeited, by order of Court. Court thereupon adjourned to 1-15 p. m.
At 1-15, Court duly opened.
J. S. Stiles vs. J. W. Reed, an action for recovery of money, continued, by consent, to next term.
Martha A. Reed vs. J. W. Reed, an action for divorce, also continued to next term.
E. L. Strauss vs. A. Gates, an action for recovery of damages for loss of property of plaintiff by defendant, in transportation, continued from last term, re-continued.
State vs. Justis A. Wilson, continued until the second Wednesday in January, A. D. 1874, at which time an adjourned term of this Court will be held to try said cause.
N. Gravelle vs. T. Gilbert and R. Armstrong, an appeal case, from Justice Court, continued to January Ad-journed Term, upon motion of plaintiff.
The Grand Jury then came into Court and filed a resolution urging payment of liquor licenses, a resolution regarding county jail, and two indictments—one against William Jones, for grand larceny; the other is withheld from the public by the Clerk—after which the Grand Jury was dismissed.
State of Minnesota vs. William Jones. Defendant arrived, and, being without counsel, J. W. Steel, Esq., was appointed by the Court as attorney for defendant. Defendant allowed to Oct. 30, 8:30 a. m., to plead to indictment. Court thereupon adjourned to 7 o'clock p. m.
At 7 p. m., Court duly opened, and case of City of Brainerd vs. Trudell & Sullivan, for violation of city ordinance, appealed from Justice Court, continued to next General Term.
Witnesses in case of State vs. J. A. Wilson, discharged until January Ad-journed term.
Court adjourned to Oct. 30, 8:30 a. m.
In the evening the Judge and Clerk, and the visiting legal gentlemen, were invited to an oyster supper by the lawyers of Brainerd, and was accepted, and enjoyed at J. M.
