To Help the Settlers. Representative Comstock has introduced an bill for the relief of settlers upon the indemnity lands that those settlers who, after Aug. 16, 1887, and before Jan. 1, 1890, settled upon those lands, may transfer their claims to other vacant government lands under the homestead and pre-emption laws. They are required to relinquish their claims to the first tract of land in the United States and where their money has been refunded they shall again make payment. The period of time and improvements for those who have not completed full shall be on the Northern Pacific land shall be allowed them in making their proof on other lands which they may select under the set. The intention and purpose of the act is to place the settlers, as nearly as may be, in the position they would have been had the lands been returned to the state at the same time as declared by the Secretary of the Interior in 1887. The lands settled upon are all in Minnesota.
