### DROWNED WHILE DUCK HUNTING.

Albert Hoppe Loses His Life in Mud Lake While Duck Hunting on Sunday Last.

Albert Hoppe, an old resident of East Brainerd, was drowned in Mud lake about 10 miles east of town late Sunday afternoon while duck hunting. Mr. Hoppe, in company with his eldest son, Albert, went out to the lake Sunday morning hoping to bag a few ducks. About five o'clock Mr. Hoppe shot a duck and it fell out in the lake beyond his reach. He found an old boat without oars and propelled the boat out a few yards where the duck was by means of sticks. He reached for the duck, and in doing so lost his balance and fell into the lake, the boat floating beyond his reach. The water was only three or four feet deep, but the bottom was a soft mud and Mr. Hoppe was soon mired in the treacherous mud so that he could not move. His son who was also anxious to wade out to assist his father but it was impossible, as he almost sank in the mud. He made loud cries when he realized the situation, and Mr. O. G. A. Lovquist, a farmer residing near, and his son, came to his assistance. They saw nothing could be done without a boat, which they procured, and went to the rescue, but by that time Mr. Hoppe had sunk further into the soft mud and drowned. They recovered his body and brought it to this city.

Mr. Hoppe was 43 years of age, and has resided in this city about 12 years, during all of which time he was employed at the N. P. shops. He was an honest, upright and industrious citizen, a kind father and indulgent husband, and had the respect of all who knew him. The funeral services were held at St. Francis Catholic church Thursday morning, Rev. Fr. Lynch officiating. He was a member of the A. O. U. W., S. of Herman, and St. Francis Society, all of the lodges attending the funeral in a body. He leaves a wife and two sons, aged 15 and 12 years to mourn his loss. He leaves his widow in comfortable circumstances, owning considerable property, and had \$4000 life insurance in the above organizations.

### Brainerd Boys Released.

Word was received in this city that Charles B. Miller and John Smith, two Brainerd boys who have been held in jail for over three months at Dubuque, Iowa for highway robbery, were given their freedom, the grand jury not returning a indictment against them. The boys were arrested at Dyerville, Ia., on July 28, accused of sand-bagging the operator on duty in the Illinois and Great West in that county, and breaking open the safe and stealing \$200. They had a preliminary examination at the time and were held to the grand jury, but have since been in jail at Dubuque. Both young men are well known here, Smith having been raised in this city, and was an apprentice at the machine shop. Young Miller was employed in the tin shop. They have had a narrow escape from a long imprisonment, and probably by this time have lost all relish for traveling about the country, broke and beating their fare.
