Also one dram of Moseley's salt, or the sub-sulphate of iron, in eight ounces of cold water, adding plenty of sugar, simply to overcome the taste of the iron. Of this solution I give from two to eight teaspoonfuls each day, according to the proximity of the disease. As it has proved so efficacious in my hands, I am anxious to have it generally tried.

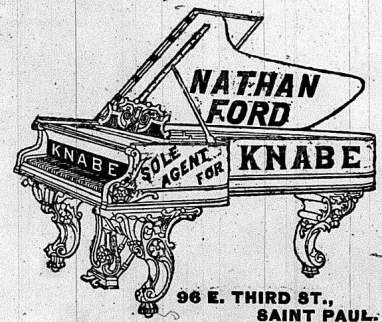
